ABSTRACT OF PROPOSAL NUMBER ONE, AN AMENDMENT

This constitutional amendment removes the special debt limit for small city school districts. Debt limits would be established in state law for all school districts.

A small city school district is one that includes at least part of a small city. A small city is a city with less than one hundred twenty-five thousand people.

The State Constitution limits how much debt a small city school district can incur. Their debt cannot be more than five percent of the value of taxable real estate in the district. There are exceptions for certain expenses. Other school districts are not subject to a constitutional debt restriction, but have a different debt limit provided by state law. State law says their debts cannot be greater than ten percent of the value of taxable real property. If this Constitutional Amendment passes, small city school districts would be eligible to have the same debt limit as other school districts enacted via legislative action.

FORM OF SUBMISSION OF PROPOSAL NUMBER ONE, AN AMENDMENT

Removal of Small City School Districts
From Special Constitutional Debt Limitation

The proposed amendment to Article 8, section 4 of the Constitution removes the special constitutional debt limitation now placed on small city school districts, so they will be treated the same as all other school districts. Shall the proposed amendment be approved?

ABSTRACT OF PROPOSAL NUMBER TWO, AN AMENDMENT

The Constitution limits the debt counties, cities, towns and villages can incur. This debt limit does not include debt for sewage treatment and disposal construction projects. The sewer debt exception expires on January 1, 2024. This amendment extends the sewer debt exception for ten more years until January 1, 2034.

The proposed amendment does this by changing section 5 of article 8 of the Constitution.

FORM OF SUBMISSION OF PROPOSAL NUMBER TWO, AN AMENDMENT

Extending Sewage Project Debt Exclusion From Debt Limit

The proposed amendment to Article 8, section 5 of the Constitution extends for ten years the authority of counties, cities, towns, and villages to remove from their constitutional debt limits debt for the construction of sewage facilities. Shall the proposed amendment be approved?

NFL: Raiders fire McDaniels, Ziegler

The Raiders fired coach **Josh McDaniels** and general manager **Dave Ziegler** late Tuesday night, the club announced.

"After much thought about what the Raiders need to move forward, I have decided to part ways with Josh and Dave," owner **Mark Davis** said in a statement. "I want to thank them both for their hard work and wish them and their families nothing but the best."

The Raiders will appoint linebackers coach and ex-Giant **Antonio Pierce** as their interim head coach according to an ESPN report. McDaniels was in the middle of his second season and went just 9-16 with Las Vegas.

NBA: Spurs rally late to defeat Suns

Keldon Johnson stripped **Kevin Durant** and made a contested layup with 1.2 seconds left to give the Spurs their only lead of the game and a 115-114 victory over the stunned Suns in Phoenix. Johnson had 27 points to lead San Antonio.

The Spurs, who trailed by as many as 20 points in the game broke a nine-game losing streak against Phoenix. First-round pick **Victor Wembanyama** had 18 points and had eight rebounds.

● In Los Angeles, **Paul George** scored 27 points, **Russell Westbrook** added 18 and the Clippers beat the Magic 118-102 as future teammate **James Harden** watched from a suite. Harden and fellow newcomer **P.J. Tucker** arrived at the arena 75 minutes before tipoff.

● Philadelphia's **Joel Embiid** was fined \$35,000 by the NBA for repeatedly making an obscene gesture during the 76ers' 126-98 victory against the Trail Blazers on Sunday in Philadelphia.

NHL: Kings remain perfect on the road

The Kings raced out to a two-goal lead in the first period and **Cam Talbot** made 30 saves in a 4-1 win over the Maple Leafs on Tuesday in Toronto. **Andreas Englund**, **Phillip Danault**, **Arthur Kaliyev** and **Adrian Kempe** scored for the Kings. Los Angeles improved to 4-0-0 in games away from home this season.

● In Vancouver, **Elias Pettersson** netted a hat trick and **Quinn Hughes** collected three assists to lead the Canucks to a 5-2 victory over the Predators.

SOCCER: Saudis make only '34 Cup bid

Saudi Arabia was the only football association to present a bid to host the 2034 FIFA World Cup before the deadline closed, soccer's global governing body said. Australia said on Tuesday it would not be presenting a bid to host the tournament, leaving Saudi Arabia as the only candidate.
