LAS VEGAS — Lexi Thompson kept a rough round from getting worse and wound up holding her own Thursday until darkness kept her from finishing at the Shriners Children's Open.

Thompson was the main attraction of this FedEx Cup Fall event, the seventh woman to play a PGA Tour event and the first in five years.

She was 1-over par for her round through 16 holes and chose to mark her ball — a 20-foot par putt on the 17th — and return to finish the first round in the morning. Still in play was a chance to make the cut, though it was hard

work to keep her score around par.
"I played decent," Thompson said. "I had one bad hole and a few iffy shots. But it's golf; it was kind of expected."

Beau Hossler set the pace by matching his career low on the PGA Tour with a 9-under 62, which included a tee shot that found the water left of the par-3 17th at the TPC Summerlin.

### **NFL:** Chiefs defeat winless Broncos

Patrick Mahomes threw for 306 yards and a touchdown, Harrison Butker kicked four field goals, and the Chiefs held off the Broncos 19-8 on Thursday night in Kansas City, Mo. for their 16th straight win over their longtime AFC West rivals.

Travis Kelce had nine catches for 124 yards for Kansas City with **Taylor Swift** again cheering him on from an Arrowhead Stadium suite. The Chiefs' defense held Russell Wilson to 95 yards passing with a touchdown and a pair of interceptions, and woebegone Denver finished with just 197 yards of total offense.

 Quarterback Justin Herbert doesn't think the broken middle finger on his left, non-throwing hand will affect him when the Chargers host the Cowboys on Monday night.

### **NHL:** Stars edge Blues in shootout

Jason Robertson and newcomer Matt Duchene scored in the shootout to help the Stars beat the Blues 2-1 in the season opener for each team in Dallas.

- In St. Paul, Minn., **Brock Faber** got his first NHL goal in the first period and Filip Gustavsson stopped 41 shots for a season-opening shutout as the Wild beat the Panthers 2-0.
- In Nashville, **Juuse Saros** made 23 saves for his 21st NHL shutout and Nashville beat the Kraken 3-0 to give Andrew Brunette his first coaching victory with the Predators.

### **GOLF:** PGA Tour getting investor interest

A memo sent to PGA Tour players Wednesday night said that while the tour works on finalizing an agreement with Saudi Arabia's Public Investment Fund, it is fielding calls from other interested investors as well, ESPN and Bloomberg reported.

- Jon Rahm got off to a solid start in his attempt to surpass Seve Ballesteros by winning a fourth Spanish Open title, shooting 4-under 67 to sit four shots off the lead after the first round in Madrid. Matthieu Pavon was at the top of the leaderboard after a 63 at the Club de Campo Villa de Madrid.
- In Shanghai, Maja Stark and Wichanee Meechai each shot 6-under 66 to take a two-stroke firstround lead at the LPGA Shanghai event.
