MILWAUKEE — Damian Lillard scored 39 points in his first game with his new team and the Bucks regrouped after blowing a 19point lead to open their season by beating the 76ers 118-117 on Thursday night in Milwaukee.

The former Trail Blazers star set a record for the most points by a player in his Bucks debut. Terry Cummings scored 34 points in his first game for the Bucks in 1984. Lillard put the Bucks ahead for good at 105-104 by sinking a 3-pointer with 3:41 remaining. His basket started an 11-0 run that gave Milwaukee a nine-point lead with 2:45 remain-

"He had the hot hand," Giannis Antetokounmpo said. "You've just got to keep on feeding him. What works, you've got to keep going to what works."

Antetokounmpo added 23 points and 13 rebounds while shooting 10 of 22 from the floor to leap past Kareem Abdul-Jabbar and become the franchise's career leader in baskets.

Tyrese Maxey scored 31, Kelly Oubre Jr. had 27 and Joel Embiid 24 for the 76ers.

## **NFL:** Bills hold off Buccaneers

Josh Allen threw two touchdown passes and ran for another — shrugging off an aggravating an injury to his throwing shoulder — and the Bills hung on to beat the Buccaneers 24-18 on Thursday night in Orchard Park, N.Y. Allen finished with 324 yards on 31-of-40 passing.

The game ended when quarterback Baker Mayfield's Hail Mary attempt from his own 45 fell between several players in the end zone. The Buccaneers have lost three straight and four of five since opening 2-0.
